### Consent for biometric fingerprinting

As part of its legal and regulatory obligations in terms of security, Geneva Airport must put in place all necessary and appropriate measures to ensure that all persons wishing to enter the security restricted area have the right to do so. Employees working on the airport must hold an Airport Identity Card (AIC) authorising them to enter this area. The AIC must **be** checked (in particular for validity, authorised areas, etc.) each time the employee enters the security zone, and Geneva Airport must ensure that the person presenting the card is in fact its holder.

At present, AICs **are** checked by security staff; this will continue to be the case in the future. However, in order to facilitate entry to the security area, Geneva Airport **has introduced** a new automatic control system at certain access points reserved for AIC holders. In order to ensure that the AIC presented actually belongs to the person wishing to enter the security zone, the automatic checks must use biometric data.

### Data processing and storage

In addition to the personal data processed for obtaining and using the AIC, the following additional personal data are processed for automated checks:

### - Fingerprints

This data is only stored on the physical AIC card and no copy is kept in Geneva Airport's IT systems, nor in any other system. When the AIC card is scanned at a control point, the system will only check that the biometric data on the AIC card matches that of the person wishing to enter the security area. The biometric data is not recorded. The data is not transmitted to third parties.

Biometrics must be used in order to use the automatic passageways; otherwise, access to the security zone will only be possible via the passageways guarded by an agent. Consent may be withdrawn at any time by contacting the Access Process Group, in which case the biometric data will be deleted from the AIC.

### **Declaration of security**

In accordance with the Swiss National Aviation Security Programme (NASP) and in particular its appendices 1-A and 4-C (List of prohibited articles) as well as the Geneva Airport Security Programme (GVA).

#### I declare:

### PHOTO ACCEPTANCE CRITERIA

- The passport photo must be 35 x 45 mm (without borders).
- Scanned photos are not accepted
- The photo must be up to date and easily recognisable by the person submitting the application.
- The face of the person submitting the application must be frontal, against a neutral background with good contrast. Profile views are not permitted.
- Photos that have already been used, are dirty, damaged or folded will not be accepted.
- The eyes must be clearly visible, even when wearing glasses
- Head coverings are not permitted, except for religious reasons.
- · Black and white photos are not accepted

A fee is charged annually to the company for the issue of each Airport Identification Card (AIC).

The Airport Identity Card (AIC) must be collected PERSONALLY from our offices, within a maximum of 60 days, on presentation of a valid identity document (identity card, passport). After this period, the airport identity card will be destroyed and a new application will have to be made.

- 3. Once tje returned document has been received, the applicant ca go to the access process group (Laissez-passer) counter, with the fully completed document.
